The Choose Love Enrichment Program has been downloaded by more than 16,000 educators in all 50 states + DC and in more than 50 countries. At the beginning of the school year of 2018-2019 it was estimated that around 500,000 students would be taught the program that year. The feedback from the program has been so overwhelmingly positive that States like New Hampshire have included it in their School Safety Commission reports and have named the Choose Love Enrichment Program as their recommended SEL program for the schools in their State. The program continues to be provided at no cost to schools thanks to generous donations and grants, as the movement is committed to ensuring that every child receives these benefits.
